

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Professional Services Agreement with the City of Tucson's Environmental Services Department guaranteeing the delivery of 4,000 tons of solid waste annually)**

**RESOLUTION NO. 15-005**

1 **WHEREAS, the Tohono O'odham Nation's Department of Natural Resources Solid Waste**  
2 **Management Program is an essential program that has been collecting,**  
3 **recycling and disposing of the Nation's solid waste since 1998; and**

4 **WHEREAS, the amount of solid waste from the Nation that is disposed of in the City of**  
5 **Tucson's Los Reales Landfill is more than 4,000 tons annually costing the Nation**  
6 **at least \$116,000.00 annually; and**

7 **WHEREAS, the Nation can enter into a "Put or Pay Agreement" with the City of Tucson which**  
8 **enables the Nation to reduce its disposal costs from \$32.00/ton to \$29.00/ton if**  
9 **the Nation guarantees to deliver at least 4,000 tons annually thereby saving at**  
10 **least \$12,000.00 annually; and**

11 **WHEREAS, the Solid Waste Management Program has delivered more than 4,000 tons**  
12 **annually for the past six years; and**

13 **WHEREAS, put or pay Professional Services Agreement has been reviewed by the Attorney**  
14 **General's Office, the Agricultural and Natural Resources Committee and the**  
15 **Budget and Finance Committee of the Legislative Council and they recommend**  
16 **its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**  
18 **approves the City of Tucson Waste Delivery/Disposal agreement substantially in**  
19 **the form attached hereto.**

20 **BE IT FINALLY RESOVLED by the Tohono O'odham Legislative Council hereby authorizes the**  
21 **Chairperson to execute the agreements, provided that any amendment affecting**  
22 **the Professional Services Agreement is submitted for further prior approval by**  
23 **the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>**  
25 **day of JANUARY, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR -0-**  
26 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
27 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
30 **June 18, 1934 (48 Stat.984).**
