

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Arizona State Purchasing Cooperative Agreement between the Arizona
Department of Administration State Procurement Office and the Tohono O'odham Nation)

RESOLUTION NO. 15-006

1 **WHEREAS, the Tohono O'odham Nation (Nation) is entering into a Cooperative State**
2 **Purchasing Agreement with the Arizona Department of Administration State**
3 **Procurement Office; and**

4 **WHEREAS, this Agreement will allow the Tohono O'odham Nation to purchase materials**
5 **and services from State contractors at the prices and terms expressed in**
6 **contracts between the State and those State's contractors; and**

7 **WHEREAS, this Agreement shall not be construed to cede any jurisdiction of either Party or**
8 **to waiver either Party's sovereign immunity in any forum or jurisdiction; and**


9 **WHEREAS, this Agreement is a term of five (5) years and may thereafter be renewed by**
10 **further action of the Legislative Council; and**

11 **WHEREAS, the Agreement has been reviewed by the Budget and Finance Committee, which**
12 **recommends approval by the Legislative Council.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
14 **approves the Arizona State Purchasing Cooperative Agreement between the**
15 **Arizona Department of Administration State Procurement Office and the**
16 **Tohono O'odham Nation substantially in the form attached hereto, and**
17 **authorizes the Chairman of the Nation to execute it.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06th**
19 **day of JANUARY, 2015 at a meeting at which a quorum was present with a vote of 2,722.3 FOR;**
20 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and 224.2[04] ABSENT, pursuant to the powers vested in the**
21 **Council by Article VI, Section 1 (f)(1) of the Constitution of the Tohono O'odham Nation,**
22 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
23 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
24 **16 of the Act of June 18, 1934 (48 Stat.984).**
