the Tohono O'odham Nation (Nation) is entering into a Cooperative State 1 WHEREAS. Purchasing Agreement with the Arizona Department of Administration State 2 3 **Procurement Office: and** this Agreement will allow the Tohono O'odham Nation to purchase materials 4 WHEREAS. 5 and services from State contractors at the prices and terms expressed in contracts between the State and those State's contractors: and 6 7 WHEREAS, this Agreement shall not be construed to cede any jurisdiction of either Party or 8 to waiver either Party's sovereign immunity in any forum or jurisdiction; and 9 WHEREAS. this Agreement is a term of five (5) years and may thereafter be renewed by 10 further action of the Legislative Council; and 11 WHEREAS, the Agreement has been reviewed by the Budget and Finance Committee, which 12 recommends approval by the Legislative Council. 13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby 14 approves the Arizona State Purchasing Cooperative Agreement between the 15 Arizona Department of Administration State Procurement Office and the 16 Tohono O'odham Nation substantially in the form attached hereto, and 17 authorizes the Chairman of the Nation to execute it. 18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH 19 day of JANUARY, 2015 at a meeting at which a quorum was present with a vote of 2,722.3 FOR; 20 -0- AGAINST; -0- NOT VOTING; and 224.2[04] ABSENT, pursuant to the powers vested in the 21 Council by Article VI, Section 1 (f)(1) of the Constitution of the Tohono O'odham Nation, 22 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting 23 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 24 16 of the Act of June 18, 1934 (48 Stat.984). 25
