

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Employment Rights Commission Budget of
\$255,000.00 for FY 2015)**

RESOLUTION NO. 15-009

1 **WHEREAS, the Tohono O'odham Nation adopted the Employment Rights Ordinance No. 01-**
2 **85 which established the Tribal Employment Rights Commission, and the**
3 **Commission is charged with carrying out the terms of the Ordinance; and**

4 **WHEREAS, the Commission applies preference in contracting and employment under the**
5 **Ordinance; as amended, 13 T.O.C. Chapter 1; and**

6 **WHEREAS, the Ordinance, in Section 1110 provides for the collection of Employment Rights**
7 **Fees from all covered employers operating within the exterior boundaries of the**
8 **Nation; and**

9 **WHEREAS, the Purpose of the Fees is to raise revenue for the operation of the Commission;**
10 **and**

11 **WHEREAS, in accordance with Section 1110 (C) of the Ordinance, the TERO fees collected**
12 **shall be expended by the Commission pursuant to budgets duly approved by the**
13 **Legislative Council to carry out the purposes of this Chapter; and**

14 **WHEREAS, the Office of the Chairman submits on behalf of the Commission the FY 2015**
15 **budget in the amount of \$255,000.00 which is within the projected balance from**
16 **FY 2014; and**

17 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**
18 **the Legislative Council have reviewed this Budget and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
20 **approves the Tribal Employment Rights Commission FY 2015 Budget in the**
21 **amount of \$255,000.00 effective October 1, 2014 through September 30, 2015.**

22 **BE IT FURTHER RESOLVED any remaining balance of TERO Fee funds shall be carried over to**
23 **the next fiscal year, provided that such funds may only be expended in**
24 **accordance with an approved budget by this Council.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorize the**
26 **Tribal Employment Rights Commission and any designated official to expend**
27 **and administer the budget as attached, provided that any amendments**
28 **affecting the funds or funding levels shall be submitted for further prior**
29 **approval by Tohono O'odham Legislative Council.**
