

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the U.S. Department of Homeland Security, Federal Emergency Management Agency 2013 Assistance to Firefighters Grant No. EMW-2013-FO-07028)

RESOLUTION NO. 15-012

1 **WHEREAS, the United States Department of Homeland Security has distributed grants to**
2 **local Fire Departments through the Federal Emergency Management Agency's**
3 **Assistance to Firefighters Grant Program to assist in providing public safety**
4 **services within their respective jurisdictions; and**

5 **WHEREAS, Indian Tribes have been designated as being eligible to receive funds through**
6 **the Assistance to Firefighter Grant Program; and**

7 **WHEREAS, the Tohono O'odham Nation had applied for the grant and has been awarded a**
8 **grant with a 5% match to be covered by the Fire Departments Tribal Budget with**
9 **an award date of June 23, 2014 through June 22, 2015; and**

10 **WHEREAS, the Tohono O'odham Nation Fire Department requests the acceptance of the**
11 **awarded grant on a reimbursement basis; and**

12 **WHEREAS, a FY 2015 budget with the Indirect Cost being waived has been submitted; and**

13 **WHEREAS, the Domestic Affairs and Budget and Finance Committees of the Legislative**
14 **Council have reviewed this Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
16 **accepts the Assistance to Firefighters Grant No. EMW-2013-FO-07028 under the**
17 **United States Department of Homeland Security, Federal Emergency**
18 **Management Agency 2013 Assistance to Firefighters Grant Program and**
19 **approval of the FY 2015 budget with a 5% match and approves a waiver of**
20 **indirect costs with an award date of June 23, 2014 through June 22, 2015.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
22 **Tohono O'odham Nation Chairperson and any designated official to expend and**
23 **administer the budget as attached, provided that any amendments affecting the**
24 **funds or funding level is submitted for further prior approval by the Tohono**
25 **O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
27 **day of JANUARY, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;**
28 **-0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
32 **June 18, 1934 (48 Stat.984).**
