5	WHEREAS,	ASARCO LLC has approached the Tohono O'odham Nation ("Nation"), the San
6		Xavier District, and the San Xavier Allottees Association with a proposal that
7		would facilitate a northward pushback of the main pit; and
8	WHEREAS,	the Nation, the San Xavier District, and the San Xavier Allottees Association has
9		requested certain information to inform their decision regarding this proposal;
10		and
11	WHEREAS,	ASARCO LLC has indicated that they will release the requested information, but
12		that the parties receiving the information must execute a confidentiality
13		agreement; and
14	WHEREAS,	the Agricultural and Natural Resources Committee has reviewed the
15		Confidentiality Agreement and recommends that it be approved.
16	NOW, THER	EFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it
17		approves the Confidentiality Agreement substantially in the form attached
18		hereto and authorizes the Chairperson of the Nation to execute it and any
19		related documents reasonably necessary to implement the Confidentiality
20		Agreement.
