3 **WHEREAS, the Attorney General recommends approval of Amendment No. 1 to the Attorney**
4 **Contract; and**

5 **WHEREAS, the Domestic Affairs Committee has reviewed Amendment No. 1 to the Attorney**
6 **Contract and recommends approval by the Legislative Council.**

7 **NOW, THEREFORE, BE IT RESOLVED that:**

- 8 **1. The Tohono O'odham Legislative Council approves Amendment No. 1 to**
9 **the Attorney Contract with the law firm of Wilmer Cutler Pickering Hale**
10 **and Dorr, LLP, for FY 2015 substantially in the form attached hereto.**
- 11 **2. The Chairperson of the Nation is authorized to execute Amendment No. 1**
12 **to the Attorney Contract.**

16 **Article VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the**
17 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
19 **June 18, 1934 (48 Stat.984).**
