18		degree of Papago-Tohono O'odham Indian blood ascribed to the
19		applicant.
20		(2) If on an application for enrollment, the date of applicant's birth the
21		membership requirement or requirements which the Council
22		found the applicant did or failed to establish.

28		of Papago-Tohono O'odham Indian blood for each applicant.
