12		applicants; or incorrect roll numbers; and
13	WHEREAS,	the Enrollment Program therefore recommends that Resolution Nos. 15-82, 09-
14		85, 92-124, 94-262, 97-221, 97-256, 97-480, 98-294, 99-080, 99-360, 02-332, 04-109,
15		04-172, 05-607, 08-644, 10-020, 14-217, and 14-465 be amended to reflect the
16		correct name spelling or roll numbers for the individuals identified in the
17		Amending Enrollment Resolution List February 2015, which is incorporated by
18		this reference; and
