**RESOLUTION NO. 15-019**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications**  
7 **and making recommendations to the Legislative Council regarding the**  
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**  
9 **and**

10 **WHEREAS, the Enrollment Program has determined that a number of resolutions**  
11 **approving applicants for membership contain misspellings in the names of**  
12 **applicants; or incorrect roll numbers; and**

13 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 15-82, 09-**  
14 **85, 92-124, 94-262, 97-221, 97-256, 97-480, 98-294, 99-080, 99-360, 02-332, 04-109,**  
15 **04-172, 05-607, 08-644, 10-020, 14-217, and 14-465 be amended to reflect the**  
16 **correct name spelling or roll numbers for the individuals identified in the**  
17 **Amending Enrollment Resolution List February 2015, which is incorporated by**  
18 **this reference; and**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**  
20 **Resolution Nos. 15-82, 09-85, 92-124, 94-262, 97-221, 97-256, 97-480, 98-294, 99-**  
21 **080, 99-360, 02-332, 04-109, 04-172, 05-607, 08-644, 10-020, 14-217 and 14-465 are**  
22 **amended upon the effective date of those resolutions to reflect the corrected**  
23 **names or roll numbers that are identified in the Amending Enrollment**  
24 **Resolution Amended List February 2015.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>**  
26 **day of FEBRUARY, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;**  
27 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
28 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**  
29 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**  
30 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
31 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
