**RESOLUTION NO. 15-023**

1 **WHEREAS, the Tohono O'odham Nation Education Department's primary goal is to revise**  
2 **and update the 1982 Comprehensive Education Plan with a focused study on BIE**  
3 **funded schools in the area of school reform; and**

4 **WHEREAS, the Department of Interior, Bureau of Indian Education has awarded the**  
5 **Tohono O'odham Nation the Sovereignty in Indian Education Grant to develop a**  
6 **plan that will support the development of a plan to improve educational**  
7 **outcomes for students and improve the efficiency and effectiveness in BIE**  
8 **funded schools; and**

9 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**  
10 **the Tohono O'odham Legislative Council have reviewed and approved the**  
11 **acceptance of the SIE Grant according to the Notice of Grant Award and the FY**  
12 **2015 SIE Grant Budget in the amount of \$200,000.00.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts the**  
14 **two-year U.S. Department of Interior, Bureau of Indian Education Sovereignty in**  
15 **Indian Education Grant in the amount of \$200,000.00 for FY 2015 to conduct**  
16 **research and an implementation plan to promote tribal control and operation**  
17 **of BIE-funded schools on the Tohono O'odham Nation and approves the FY 2015**  
18 **U.S. Department of the Interior, Bureau of Indian Education SIE Grant Budget.**

19 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation Department of Education is**  
20 **authorized to expend the funds from this grant in accordance with the terms**  
21 **and conditions of the U.S. Department of the Interior, Bureau of Indian**  
22 **Education Sovereignty in Indian Education Grant Program from October 1, 2014**  
23 **to September 30, 2015.**

24 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes**  
25 **the Chairperson or any designated official to execute the award documents for**  
26 **the acceptance.**

27 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
28 **Chairperson and any designated official to expend and administer the budget as**  
29 **attached, provided that any amendments affecting the funds or funding level is**  
30 **submitted for further prior approval by the Tohono O'odham Legislative**  
31 **Council.**
