

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment #1 to the Intergovernmental Agreement with the Arizona Department of Economic Security regarding Workforce Investment Act funding for the One Stop Division)

RESOLUTION NO. 15-025

1 **WHEREAS, the Tohono O'odham Nation and the Arizona Department of Economic Security**
2 **executed an Intergovernmental Agreement (IGA) under which the Nation**
3 **receives funds for specific Workforce Investment Act (WIA) employment and**
4 **training programs operated by the Education Department One Stop Division**
5 **(Contract No. DE15-077080); and**

6 **WHEREAS, Amendment #1 has been received to incorporate FY 15 funding to set the new**
7 **reimbursement ceilings to \$523,655.00 from \$232,626.00 for grant funding for**
8 **the current IGA in place from April 1, 2013 to June 30, 2014, and to add certain**
9 **provisions required by the U.S. Department of Labor; and**

10 **WHEREAS, the Arizona Department of Economic Security has allocated funds to the Nation**
11 **for FY 2015 in the amount of \$291,029 for the period beginning July 1, 2014 to**
12 **June 30, 2015; and**

13 **WHEREAS, the Human Resources Development Committee has reviewed the Arizona**
14 **Department of Economic Security Intergovernmental Agreement and**
15 **recommend it's approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
17 **approves, and authorizes Amendment No. 1 to the Intergovernmental**
18 **Agreement between the Nation and the Arizona Department of Economic**
19 **Security substantially in the form attached hereto, and authorizes the Chairman**
20 **of the Tohono O'odham Nation to execute it.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
22 **day of FEBRUARY, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;**
23 **-0- AGAINST; [01] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council**
24 **by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**
25 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
27 **June 18, 1934 (48 Stat.984).**
