RESOLUTION NO. 15-026

1 **WHEREAS, the Tohono O'odham Nation submitted an application for funding under the**
2 **U.S. Department of Justice Coordinated Tribal Assistance Solicitation, Fiscal**
3 **Year 2013, Purpose Area 2: Comprehensive Tribal Justice System Strategic**
4 **Planning - Bureau of Justice Assistance (BJA) in the amount of \$75,000.00 from**
5 **October 01, 2013 through March 31, 2015 (18 months); and**

6 **WHEREAS, the Nation was informed it was awarded and received Notice of award dated**
7 **September 18, 2013 for grant project period from October 01, 2013 through**
8 **March 31, 2015, to complete the strategic planning in collaboration with**
9 **Nation's Justice Department; and**

10 **WHEREAS, a budget has been prepared for Fiscal Year 2015 with a fiscal year October 1,**
11 **2014 through March 31, 2015; and**

12 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**
13 **Legislative Council have reviewed this Budget and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
15 **approves the U.S. Department of Justice, Office of Justice Programs (OJP)**
16 **Comprehensive Tribal Justice Systems Strategic Planning Award No. 2013-IC-BX-**
17 **0017 FY 2015 Budget in collaboration with the Tohono O'odham Nation's Justice**
18 **Department in the amount of \$72,729.62 and to utilize the Nation's resources**
19 **pending reimbursement from the grantor for the continuation of this grant.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
21 **Chairperson and any designated official to expend and administer the budget as**
22 **attached, provided that any amendments affecting the funds or funding level is**
23 **submitted for further prior approval by the Tohono O'odham Legislative**
24 **Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
26 **day of FEBRUARY, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(f) and 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted**
29 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
30 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
31 **Act of June 18, 1934 (48 Stat.984).**


