12		and by October 2017 at the pump and is required Nationwide by card holders for
13	:	all merchants to have, if the deadline is not met, card issuers reserve the right to
14		shift fraud liability to the merchants; and
15	WHEREAS,	the proposed budget and it's justification was reviewed and approved by the
16		Sells District Council with Resolution No. SD-06-15; and
17	WHEREAS,	the amount of \$126,909.91 will be taken out of the Supplement Account that Sells
18		District has with Morgan Stanley Smith Barney; and
19	WHEREAS,	the Budget and Finance Committee of the Tohono O'odham Legislative Council
20		has reviewed the budget and recommends it's approval.
21	NOW THERE	FORE BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
22		supplement amount of \$126,909.91 from the Supplement Account that Sells
23		District has with Morgan Stanley Smith Barney for Shell Convenience to
