

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Well Maintenance FY 2015 Budget Amendment No. 1)**

RESOLUTION NO. 15-033

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2015 Budget for the**
2 **Department of Natural Resource Well Maintenance Program by Resolution No.**
3 **14-353; and**

4 **WHEREAS, the Well Maintenance Program has prepared and submitted for review and**
5 **approval FY 2015 Budget Amendment No. 1; and**

6 **WHEREAS, amendment No. 1 will allow to create line item 7210 Dues and Subscriptions and**
7 **decrease Operational Expense line item; and**

8 **WHEREAS, no change to the base budget amount; and**

9 **WHEREAS, the Water Resources and the Budget and Finance Committees of the Legislative**
10 **Council have reviewed this Budget Amendment No. 1 and recommends its**
11 **approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
13 **approves the Well Maintenance Program Budget Amendment No.1 to create a**
14 **new line item, decrease Operational Expense line item with no change to the**
15 **base budget amount of \$517,320.42.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
17 **Chairperson and any designated official to expend and administer the budget,**
18 **as attached, provided that any amendments affecting the funds or funding**
19 **levels of the budget shall be submitted for further prior approval by the Tohono**
20 **O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
22 **day of FEBRUARY, 2015 at a meeting at which a quorum was present with a vote of 2,749.6 FOR;**
23 **-0- AGAINST; -0- NOT VOTING; and 196.9[05] ABSENT, pursuant to the powers vested in the**
24 **Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation,**
25 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
26 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
27 **16 of the Act of June 18, 1934 (48 Stat.984).**
