

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2015 Budget Amendment #1 for the Tohono O'odham Judicial Branch)

RESOLUTION NO. 15-034

1 **WHEREAS, the Tohono O'odham Legislative Council approved FY 2015 Judicial Branch**
2 **budget with Resolution No. 14-347 at \$6,412,715.55; and**

3 **WHEREAS, the Judicial Branch has evaluated the positions within the branch and has**
4 **determined that there is a need to increase the number of Juvenile Detention**
5 **Officer from (15) to (19) Officers; and**

6 **WHEREAS, the Court Officer Division has taken on additional duties and the salaries will be**
7 **increased for (1) Court Officer I from \$41,748.00 to \$48,414.00 and (5) Court**
8 **Officers from \$34,264.00 to \$37,821.00; and**

9 **WHEREAS, the Judicial Branch has determined that the number of (8) Probation Officers**
10 **(Juvenile) can be reduced to (4) Probation Officers (Juvenile) without substantial**
11 **effect on the quality of services; and**

12 **WHEREAS, the Judicial Branch has determined that it would be beneficial to utilize the**
13 **salaries of the (4) Probation Officers to fund the new positions of (4) Juvenile**
14 **Detention Officers, and the Court Officer's salary increase; and**

15 **WHEREAS, the following new line items would be added to the budget: 6530 Transportation**
16 **and 6700 Awards; and**

17 **WHEREAS, the Judicial Branch has prepared the attached Budget Amendment #1 to reflect**
18 **the changes listed above; and**

19 **WHEREAS, this Amendment to the budget will not increase the total overall budget of**
20 **\$6,412,715.55; and**

21 **WHEREAS, the Judiciary and the Budget and Finance Committees of the Legislative Council**
22 **have reviewed this budget and recommend its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby approves**
24 **the attached FY 2015 Budget Amendment #1 for the Tohono O'odham Judicial**
25 **Branch to:**

- 26 **1. Include the new positions of (4) Juvenile Detention Officers effective 40**
27 **days after final approval of this resolution.**
- 28 **2. Increase the salary of (1) Court Officer I from \$41,748.00 to \$48,414.00 and**
29 **(5) Court Officers positions from \$34,264.00 to \$37,821.00.**
- 30 **3. Delete the positions of (4) Probation Officers (Juvenile) effective 40 days**
31 **after final approval of this resolution.**

3 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
4 **Chief Judge and any designated official to expend and administer the budget as**
5 **attached, provided that any amendments affecting the funds or funding level**
6 **shall be submitted for further prior approval by the Tohono O'odham**
7 **Legislative Council.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
9 **day of FEBRUARY, 2015 at a meeting at which a quorum was present with a vote of 1,378.4 FOR;**
10 **1,371.2 AGAINST; -0- NOT VOTING; and 196.9[06] ABSENT, pursuant to the powers vested in the**
11 **Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation,**
12 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
13 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
14 **16 of the Act of June 18, 1934 (48 Stat.984).**




