

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Recognition of Relinquishment from membership in the Tohono O'odham Nation**  
**for the month of March 2015)**

**RESOLUTION NO. 15-047**

1 **WHEREAS, Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests**  
2 **the Tohono O'odham Legislative Council with the power to "enact laws and**  
3 **ordinances governing the enrollment and adoption of members and the**  
4 **relinquishment and loss of membership"; and**

5 **WHEREAS, in accordance with the Tohono O'odham Nation's Enrollment Ordinance,**  
6 **Ordinance No. 05-81 as amended the Enrollment Committee has received a**  
7 **written statement from 1 tribal member who have expressed their intent to**  
8 **relinquish their membership with the Tohono O'odham Nation and the member**  
9 **is identified in the March 2015 Relinquishment List, which is incorporated by**  
10 **this reference; and**

11 **WHEREAS, pursuant to Article IX Section 1 of the Enrollment Ordinance,**  
12 **A member of the Nation may relinquish his membership in the Nation by**  
13 **submitting a written statement clearly expressing an intent to relinquish his**  
14 **membership to the Council, a copy of which must be served on the committee.**  
15 **The written statement must be signed by the person wishing to relinquish his**  
16 **membership or, if a minor or incompetent, by the parent(s), guardian or other**  
17 **person legally authorized to act on his behalf. Relinquishment does not require**  
18 **the approval of the Council, but is effective upon receipt of the statement by the**  
19 **Council and cannot be subsequently denied. Upon recognition by the Council**  
20 **that the individual has renounced his membership, his name shall be deleted**  
21 **from the membership roll.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
23 **recognizes that the individual identified in the March 2015 Relinquishment List**  
24 **has relinquished their membership in the Tohono O'odham Nation and orders**  
25 **the removal of their name from the Nation's membership roll.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02<sup>ND</sup>**  
27 **day of MARCH, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation, adopted by the**  
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
32 **June 18, 1934 (48 Stat.984).**
