RESOLUTION NO. 15-048

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications**
7 **and making recommendations to the Legislative Council regarding the**
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**
9 **and**

10 **WHEREAS, the Enrollment Program has determined that a number of resolutions**
11 **approving applicants for membership contain misspellings in the names of**
12 **applicants; or incorrect roll numbers; and**

13 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 201-86, 97-**
14 **036, 97-256, 98-034, 98-083, 99-039, 99-360 and 06-222 be amended to reflect the**
15 **correct name spelling or roll numbers for the individuals identified in the**
16 **Amending Enrollment Resolution List March 2015, which is incorporated by this**
17 **reference.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
19 **Resolution Nos. 201-86, 97-036, 97-256, 98-034, 98-083, 99-039, 99-360 and 06-**
20 **222 are amended upon the effective date of those resolutions to reflect the**
21 **corrected names or roll numbers identified in the Amending Enrollment**
22 **Resolution List March 2015.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND**
24 **day of MARCH, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
26 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**
27 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**
28 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
29 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
