

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Certification of Additional Tohono O'odham Nation Eligible Adult
Member for the Fourth Per Capita Distribution)**

RESOLUTION NO. 15-051

1 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the**
2 **"Tohono O'odham Voice in the Use of Gaming Revenues" ("Initiative"), which**
3 **authorizes per capita payments to the Nation's members provided that**
4 **sufficient gaming revenues are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono**
6 **O'odham Nation ("Gaming Ordinance") was subsequently amended to authorize**
7 **per capita distribution payments in accordance with the Initiative (See**
8 **Legislative Council Resolution No. 97-303); and**

9 **WHEREAS, the Legislative Council adopted the Per Capita Revenue Allocation Plan for a per**
10 **capita distribution per Legislative Council Resolution No. 09-164; and**

11 **WHEREAS, the Chairman of the Nation received written notification from the Department**
12 **of the Interior on June 15, 2009 that the Nation's Revenue Allocation Plan is**
13 **approved; and**

14 **WHEREAS, the Nation's Department of Membership Services, Enrollment Program submits**
15 **to the Tohono O'odham Legislative Council the certification Listing for eligible**
16 **adult member for review and approval for a fourth per capita distribution; and**

17 **WHEREAS, pursuant to Resolution No. 09-428 which approved the Master List for**
18 **certification, the initial number of verified adult eligible member for the fourth**
19 **per capita distribution is 19,141; and**

20 **WHEREAS, the disbursement of funds to each eligible adult member is contingent upon**
21 **verification of a member and further certification by the Tohono O'odham**
22 **Legislative Council.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
24 **approves the certification of 3 additional adult members for the fourth per**
25 **capita distribution.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND**
27 **day of MARCH, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
32 **June 18, 1934 (48 Stat.984).**
