

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Repealing Legislative Order No. 15-041 "Recessing March 3, 2015 General Session for  
Scheduled Electrical Outage")**

**LEGISLATIVE ORDER NO. 15-053**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**  
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**  
3 **committees, boards and special committees." (Constitution of the Tohono**  
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, Article I, Section 1(A) of the Legislative Rules of the Tohono O'odham Legislative**  
6 **Council, provides that, "Prior to an official adjournment, the Tohono O'odham**  
7 **Legislative Council ("Legislative Council") shall adopt a legislative calendar ..."**  
8 **specifying general session dates; and**

9 **WHEREAS, Article 1, Section 1(A)(2) of the Legislative Rules provides that, "The legislative**  
10 **calendar shall not be changed without Legislative Council approval."; and**

11 **WHEREAS, on February 13, 2015, the Legislative Council passed Legislative Order No. 15-041**  
12 **recessing the March 3, 2015 general session for a scheduled electrical outage;**  
13 **and**

14 **WHEREAS, the electrical outage has been rescheduled and there is no longer a need to**  
15 **recess Legislative Council general session on March 3, 2015.**

16 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it repeals**  
17 **Legislative Order No. 15-041 "Recessing March 3, 2015 General Session for**  
18 **Scheduled Electrical Outage."**

19 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 02<sup>TH</sup> day of**  
20 **MARCH, 2015 at a meeting at which a quorum was present with a vote of 2,477.75 FOR; 468.75**  
21 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
22 **Article VI, Section 1(a) & 1(d) of the Constitution of the Tohono O'odham Nation, adopted by the**  
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
25 **June 18, 1934 (48 Stat.984).**
