

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2015 Budget Amendment #1 for the Baboquivari District Administration,**  
**in the amount of \$24,232.50 and to create Line Item 6004 – District Bonus)**

**RESOLUTION NO. 15-057**

1 **WHEREAS, Baboquivari District Administration presented the FY 2015 Budget Amendment**  
2 **#1 for the Baboquivari District Administration (see attached Budget); and**

3 **WHEREAS, Amendment #1 would create Line Item 6004-District Bonus in the amount of**  
4 **\$22,500.00, also adding additional funding of \$1,732.50 to 6110-FICA Line item;**  
5 **and**

6 **WHEREAS, the District has identified that there is sufficient funding available in the**  
7 **Baboquivari District, Money Market Account to cover the Bonus including the**  
8 **taxes; and**

9 **WHEREAS, Budget Amendment #1 will increase the Administration's FY 2015 original**  
10 **budget amount of \$595,662.82 to a revised amount of \$619,895.32 and will also**  
11 **increase the overall District's FY 2015 budget of \$2,018,876.06 to a revised**  
12 **amount of \$2,043,108.56; and**

13 **WHEREAS, the Budget and Finance Committee of the Legislative Council has reviewed the**  
14 **attached Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
16 **approves the FY 2015 Baboquivari District Budget Amendment #1 which will:**

- 17 **1. Create new Line Item 6004 – District Bonus.**
- 18 **2. Increase the Administration's FY 2015 original budget amount of**  
19 **\$595,662.82 to a revised amount of \$619,895.32.**
- 20 **3. Increase the overall Baboquivari District's FY 2015 Budget amount of**  
21 **\$2,018,876.06 to a revised amount of \$2,043,108.56.**

22 **BE IT FURTHER RESOLVED that the amount of \$24,232.50 will come from the Baboquivari**  
23 **District, Money Market Account.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
25 **District Chairperson and any designated official to expend and administer the**  
26 **Budget as attached, provided that any Modifications/Amendments affecting the**  
27 **funds or funding level is submitted for further prior approval by the Tohono**  
28 **O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02<sup>ND</sup>**  
30 **day of MARCH, 2015 at a meeting at which a quorum was present with a vote of 2,675.9 FOR;**  
31 **270.6 AGAINST; [01] NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the**  
32 **Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation,**  
33 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
34 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
35 **16 of the Act of June 18, 1934 (48 Stat.984).**
