1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2015 Budget for the**
2 **Department of Public Safety Office of Emergency Management by Resolution No.**
3 **14-353; and**

4 **WHEREAS, the Office of Emergency Management has prepared and submitted for review**
5 **and approval the FY 2015 Budget Amendment #1; and**

6 **WHEREAS, the Tohono O'odham Nation has been awarded a grant from the U.S.**
7 **Department of Homeland Security, FEMA as part of the Hazard Mitigation Grant**
8 **Program for Mitigation Education and Outreach, Grant #FEMA-DR-AZ-Tohono**
9 **O'odham Nation; and**

10 **WHEREAS, the Tohono O'odham Nation has also been awarded a grant from the Arizona**
11 **Department of Emergency and Military Affairs, Arizona Division of Emergency**
12 **Management as part of the FFY 2014 Emergency Management Performance**
13 **Grant (EMPG), Grant #EMW-2014-EP-000016; and**

14 **WHEREAS, Amendment #1 will reflect a twenty five percent (25%) match for the Hazard**
15 **Mitigation Grant and fifty percent (50%) match for the Emergency and Military**
16 **Affair Grant for cost share requirements for the respective grants; and**

17 **WHEREAS, Amendment #1 will adjust the Operational Expense line items and create line**
18 **item 7500 Major Capital to cover the Tribal Match requirements; and**

19 **WHEREAS, there will be no change to the base budget amount; and**

20 **WHEREAS, the Domestic Affairs and the Budget and Finance Committees of the Legislative**
21 **Council have reviewed this Budget Amendment #1 and recommend it's**
22 **approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
24 **the Budget Amendment #1 of the Office of Emergency Management FY 2015**
25 **Tribal Budget to:**

- 26 **1. Approve Tribal budget match of twenty-five percent (25%) for the Hazard**
27 **Mitigation Grant and fifty percent (50%) for the Emergency and Military**
28 **Affairs Grant.**
