

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Chukut Kuk District FY 2015 Budget Amendment No. 3)**

RESOLUTION NO. 15-071

1 **WHEREAS, Tohono O'odham Legislative Council by resolution No. 14-423 approved Chukut**
2 **Kuk District FY 2015 Budget in the amount of \$1,767,132.72; and**

3 **WHEREAS, the Chukut District FY 2015 Budget was amended by Tohono O'odham**
4 **Legislative Council by Resolution No. 14-482, Amendment No. 1, that increased**
5 **the budget by \$114,663.55 also by Resolution No. 15-007, Amendment No. 2,**
6 **which increased the budget by \$8,000.00; and**

7 **WHEREAS, Amendments No. 1 and No. 2 has increased the overall Chukut Kuk District FY**
8 **2015 budget to \$1,889,796.27; and**

9 **WHEREAS, the Chukut Kuk District Council approved Amendment No. 3 by Resolution No.**
10 **2015-12 to allow FY 2014 surplus carry over in the amount of \$57,995.97 for**
11 **Vamori, San Miguel, West Villages, Williams Ranch, Ston Sudagi, Horseshoe**
12 **Ranch and Miguel Communities; and**

13 **WHEREAS, Chukut Kuk District FY 2015 Budget Amendment No. 3 was reviewed by the**
14 **Tohono O'odham Legislative Council Budget and Finance Committee and**
15 **recommends its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
17 **approves Chukut Kuk District FY 2015 Budget Amendment No. 3.**

18 **BE IT FURTHER RESOLVED that FY 2014 surplus funds will be added to various line items in the**
19 **FY 2015 Community Budgets to cover anticipated costs, increasing the FY 2015**
20 **District Budget from \$1,889,796.27 to \$1,947,792.24.**

21 **Vamori Community will carry over \$2,133.26 increasing FY 2015 budget**
22 **to \$37,688.57.**

23 **San Miguel Community will carry over \$16,175.80 increasing FY 2015**
24 **budget to \$56,175.80 and adding new line item: 810-Professional**
25 **Services.**

26 **West Villages Community will carry over \$16,048.81 increasing FY 2015**
27 **budget to \$56,048.81 and adding new line item 892- Non Major Capital**
28 **Equipment.**

29 **Williams Ranch Community will carry over \$8,710.55 increasing FY**
30 **2015 budget to \$28,710.55.**

Ston Sudagi Community will carry over \$4,257.14 increasing FY 2015 budget to \$24,257.14 and inserting "and meals" in budget justification for line item 660-Travel.


Horseshoe Ranch Community will carry over \$1,832.65 increasing FY 2015 budget to \$21,832.65 and amending budget justification to read: Surplus monies to be used to send one (1) Horseshoe Ranch community youth to the yearly UNITY conference and that all expenses be paid (registration, per diem, airfare, lodging, etc.) and inserting "cell phone" in budget justification for line item 710-Utilities.

Miguel Community will carry over \$8,837.76 increasing FY 2015 budget to \$48,837.76.

BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the District Chairperson and any designated official to expend and administer the budget as attached provided that any modifications/amendments affecting the funds or funding level of the Chukut Kuk District FY 2015 budget shall be submitted to the Tohono O'odham Legislative Council for prior approval.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH day of MARCH, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
