13		PCWIN radio equipment to the Nation; and
14	WHEREAS,	the Drexel Heights Fire District will act as the billing administrator in order to
15		pass along PCWIN monthly radio subscription fees; and
16	WHEREAS,	the agreement shall be in effect for the time period October 1, 2014 to
17	<u> </u>	September 30, 2015; and
18	WHEREAS,	the Domestic Affairs Committee and the Budget and Finance Committee have
19		reviewed the proposed agreement and recommend approval by the Legislative
20		Council.
21	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves
22		the Radio Use Agreement with the Drexel Heights Fire District substantially in
23		the form attached hereto and authorizes the Chairman of the Tohono O'odham
