

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Holding April 10, 2015 General Session in Puerto Peñasco, Mexico for an Economic  
Development Authority Presentation)**

**LEGISLATIVE ORDER NO. 15-075**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**  
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**  
3 **committees, boards and special committees." (Constitution of the Tohono**  
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, Article I, Section 2(C) of the Legislative Rules of the Tohono O'odham Legislative**  
6 **Council, as amended, provides that "[a]ll Legislative Council sessions shall be**  
7 **held at the Tohono O'odham Legislative Council chambers located in Sells,**  
8 **Tohono O'odham Nation, with the following exceptions. . . [a] majority of all the**  
9 **legislative representatives may vote to hold a session in some location other**  
10 **than the chambers located at Sells."; and**

11 **WHEREAS, the Commerce Committee has requested the Legislative Council hold its April**  
12 **10, 2015 general session in Puerto Peñasco, Mexico for an Economic**  
13 **Development Authority presentation.**

14 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that the April**  
15 **10, 2015 general session shall be held in Puerto Peñasco, Mexico for an**  
16 **Economic Development Authority presentation and roll call shall be taken at**  
17 **10:30 a.m. at Princesa de Peñasco.**

18 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 31<sup>ST</sup> day of**  
19 **MARCH, 2015 at a meeting at which a quorum was present with a vote of 2,946.50 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
21 **Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
24 **June 18, 1934 (48 Stat.984).**
