| 14 | | membership to the Council, a copy of which must be served on the committee. |
| 15 | | The written statement must be signed by the person wishing to relinquish his |
| 16 | | membership or, if a minor or incompetent, by the parent(s), guardian or other |
| 17 | | person legally authorized to act on his behalf. Relinquishment does not require |
| 18 | | the approval of the Council, but is effective upon receipt of the statement by the |
| 19 | | Council and cannot be subsequently denied. Upon recognition by the Council |
| 20 | | that the individual has renounced his membership, his name shall be deleted |
| 21 | | from the membership roll. |
