

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Sells District - North Communities Mining Royalties Carryover from FY 2014)

RESOLUTION NO. 15-078

1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 13-460 approved the**
2 **apportionment of Mining Royalties by 50/50 Distribution to the districts; and**

3 **WHEREAS, the FY 2014 Mining Royalties amount allocated to Sells District was in the**
4 **amount of \$137,525.48; and**

5 **WHEREAS, the Mining Royalties allocation of \$137,525.48 was distributed evenly between**
6 **the four communities at an amount of \$34,381.37 and was approved by each**
7 **community by Resolution No. CC-24-14 for Cowlic Community; Resolution No.**
8 **GO-35-2014 for Ge Oidag Community; Resolution No. NC 86-14 for North**
9 **Communities and Resolution No. SC-038-14 for Sells Community; and**

10 **WHEREAS, Sells District Council did approve the equal distribution of the Mining Royalties**
11 **budget for the Sells District Communities in the amount of \$34,381.37 with**
12 **Resolution No. SD-28-14; and**

13 **WHEREAS, North Communities did not utilize all of the 2014 Mining Royalties allocation of**
14 **\$34,381.37 and would like to carry over the remaining amount of \$32,276.57 to**
15 **FY 2015 per resolution #NC 46-15 with attached budget; and**

16 **WHEREAS, the Budget and Finance Committee of the Tohono O'odham Legislative Council**
17 **has reviewed the budget and recommends its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
19 **Sells District - North Communities Mining Royalties Budget from Fiscal Year**
20 **2014 to be carried over to Fiscal Year 2015 in an amount of \$32,276.57.**

21 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
22 **Sells District Chairperson and any designated District Official to expend and**
23 **administer the budget as attached, provided that any modifications or**
24 **amendments affecting the funds or funding levels of the budget shall be**
25 **submitted for further prior approval by the Tohono O'odham Legislative**
26 **Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
28 **day of APRIL, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
31 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
33 **June 18, 1934 (48 Stat.984).**
