

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the One Stop Division Bureau of Indian Affairs P.L. 102-477 Budget  
Amendment #1 for FY 2014 Carry Forward Funds)**

**RESOLUTION NO. 15-084**

1 **WHEREAS, the Bureau of Indian Affairs P.L. 102-477 Budget combines federal program**  
2 **funds under the Tohono O'odham Nation Education Department One Stop**  
3 **Division from October 1, 2014 to September 30, 2015 in the combined amount of**  
4 **\$1,223,708.72 for FY 2015; and**

5 **WHEREAS, the P.L. 102-477 Budget had been developed and cost shared with the Arizona**  
6 **Department of Economic Security funding to promote transitional services for**  
7 **clients with an effective cost share to promote de-centralized services; and**

8 **WHEREAS, Grants and Contracts have identified a FY 2014 year-end balance in the amount**  
9 **of \$450,596.71 and the One Stop Division submits a budget amendment to the FY**  
10 **2015 P.L. 102-477 Budget to include the carry forward amount which increases**  
11 **the budget total; and**

12 **WHEREAS, Amendment #1 will adjust Personnel Line Items and create line items 6530**  
13 **Transportation, 6700 Awards, 7015 Uniforms, 7035 Building Materials, and 7420**  
14 **RM Building and increases Operational Expense line items; and**

15 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**  
16 **the Legislative Council have reviewed this budget amendment #1 and**  
17 **recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
19 **approve and authorize FY 2015 P.L. 102-477 Budget Amendment #1 for the**  
20 **Education Department - One Stop Division which will:**

- 21 **1. To carry forward FY 2014 funds in the amount of \$431,994.94.**
- 22 **2. Increases and decreases Personnel Expense line items.**
- 23 **3. Creates new line items and increasing Operational Expense line items.**
- 24 **4. Increase overall budget amount from \$1,223,708.72 to \$1,656,305.43.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
26 **Chairperson and any designated official to expend and administer the budget as**  
27 **attached, provided that any amendments affecting the funds or funding level is**  
28 **submitted for further prior approval by the Tohono O'odham Legislative**  
29 **Council.**
