

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Office of Attorney General Budget Amendment No. 1 for FY 2015)**

RESOLUTION NO. 15-089

1 **WHEREAS, the Office of Attorney General has overall responsibility for providing legal**
2 **advice and representation to all officials, agencies, departments, divisions and**
3 **branches of the Nation's government, and provides some of these legal services**
4 **through attorney contracts; and**

5 **WHEREAS, the FY 2015 budget was approved by Tohono O'odham Legislative Council**
6 **Resolution No. 14-353; and**

7 **WHEREAS, a budget amendment has been prepared and submitted for approval requesting**
8 **additional funding from the General Fund Account to increase the budget; and**

9 **WHEREAS, Amendment No. 1 will allow the increase of line item 7355 Professional Services**
10 **increasing funding to be used for the Tohono O'odham Nation's attorney**
11 **contracts; and**

12 **WHEREAS, Amendment No. 1 will allow additional funding for the attorney contract with**
13 **the law firm of Sonosky, Chambers, Sachse, Miller & Munson, LLP (the "Sonosky**
14 **law firm") for FY 2015, for the period from October 1, 2014 to September 30, 2015,**
15 **which was approved by Legislative Council Resolution No. 14-448, for legal**
16 **services involving the Tohono O'odham Nation's P.L. 93-638 Indian Self-**
17 **Determination Act contract with the Indian Health Service; and**

18 **WHEREAS, the Health and Human Services, the Domestic Affairs, and the Budget and**
19 **Finance Committees have reviewed this Amendment No. 1.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
21 **the Office of Attorney General FY 2015 Budget Amendment No. 1 adding \$144,000**
22 **to the Office's professional services line item, to be appropriated from the**
23 **general fund.**


24 **BE IT FURTHER RESOLVED that the general fund shall be reimbursed this amount from a**
25 **settlement with the United States of approximately \$530,000 settling the**
26 **Nation's administrative claims for contract support costs for certain years**
27 **against the Indian Health Service, which is currently being finalized with the**
28 **United States Department of Justice**

29 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
30 **Chairperson and any designated official to expend and administer the budget as**
31 **attached, provided that any budget amendments affecting the funds or funding**


1 levels shall be submitted for further prior approval by the Tohono O'odham
2 Legislative Council.

3 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH
4 day of APRIL, 2015 at a meeting at which a quorum was present with a vote of 2,652.7 FOR; 293.8
5 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
6 Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
7 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
8 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
9 June 18, 1934 (48 Stat.984).


