(Approving the Special Diabetes Program for Indians (SDPI) Carry Forward Award  
for the Healthy O'odham Promotion Program (HOPP) FY 2015 Budget Amendment #1)**

**RESOLUTION NO. 15-090**

1   **WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Program for Indians**  
2                   **(SDPI) grant funded by the Indian Health Service, Division of Diabetes**  
3                   **Treatment and Prevention through September 30, 2015 with a base budget**  
4                   **amount of \$1,929,827.00; and**

5   **WHEREAS, Tohono O'odham Department of Health & Human Services Division Healthy**  
6                   **O'odham Promotion Program was notified of a carry forward to be added to the**  
7                   **approved budget by Legislative Resolution No. 14-358; and**

8   **WHEREAS, the Healthy O'odham Promotion Program has prepared budget amendment No.**  
9                   **1 to utilize the carry forward savings of \$961,855.00 to add new line items; and**

10   **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**  
11                   **Legislative Council have reviewed this budget and recommend its approval.**

12   **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
13                   **approve and authorize expenditures to utilize the Nation's resources pending**  
14                   **reimbursement from the Grantor for the continuation of this grant:**

- 15           1.    **Acceptance of the Notice of Award (NOA) for project period October 1,**  
16                   **2013 through September 30, 2015.**
- 17           2.    **Approve the creating of new line items 7010 Uniforms; 7020 Supplies-**  
18                   **Kitchen; 7300 Advertising; 7500 Major Capital Equipment, increasing**  
19                   **operational expense line items.**
- 20           3.    **Approve the change in total budget amount to \$2,891,682.**

21   **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
22                   **Chairman and any designated official to expend and administer the budget, as**  
23                   **attached, provided that any amendments affecting the funds or funding level**  
24                   **shall be submitted for further prior approval by the Tohono O'odham**  
25                   **Legislative Council.**

26   **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>**  
27   **day of APRIL, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**  
28   **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
29   **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
30   **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31   **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
32   **June 18, 1934 (48 Stat.984).**
