8	WHEREAS,	the Healthy O'odham Promotion Program has prepared budget amendment No.
9		1 to utilize the carry forward savings of \$961,855.00 to add new line items; and
10	WHEREAS,	the Health and Human Services and the Budget and Finance Committees of the
11		Legislative Council have reviewed this budget and recommend its approval.

17		2. Approve the creating of new line items 7010 Uniforms; 7020 Supplies-
18		Kitchen; 7300 Advertising; 7500 Major Capital Equipment, increasing
19		operational expense line items.
20		3. Approve the change in total budget amount to \$2,891,682.
