5 **Attorney Contract; and**


6 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed**

12 **Miller & Munson, LLP for FY 2015 substantially in the form attached**

- 14 **2. The Chairperson of the Nation is authorized to execute Amendment No. 1**
15 **to the Attorney Contract.**

19 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
20 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
22 **June 18, 1934 (48 Stat.984).**
