

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2015 Human Resources Department Budget Amendment #1)**

**RESOLUTION NO. 15-093**

1 **WHEREAS, the Human Resources Department provides general support services for the**  
2 **Executive Branch, Legislative Branch, Judicial Branch, the Districts, and two**  
3 **entities of the Nation; and**

4 **WHEREAS, the original Human Resources Budget was approved by Resolution No. 14-353**  
5 **from October 01, 2014 through September 30, 2015; and**

6 **WHEREAS, the Human Resources Department has prepared a budget Amendment #1 to**  
7 **adjust line items within the budget and to add line items 7340 Public Relations,**  
8 **7420 RM Building and 7500 Major Capital Equipment per the attached budget**  
9 **with no change to the original allocation and to meet the needs for the**  
10 **remainder of the fiscal year; and**

11 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**  
12 **the Legislative Council have reviewed this Budget Amendment #1 and**  
13 **recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
15 **approves the budget Amendment adding new line items 7340 Public Relations,**  
16 **7420 RM Building and 7500 Major Capital Equipment and modifying line items**  
17 **per the attached budget with no change to the total original allocation.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
19 **Chairperson and any designated official to expend and administer the Budget as**  
20 **attached, provided that any Amendments affecting the funds or funding level is**  
21 **submitted for further prior approval by the Tohono O'odham Legislative**  
22 **Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>**  
24 **day of APRIL, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
26 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
29 **June 18, 1934 (48 Stat.984).**
