Security Grant Program (THSGP), Grant Award No. EMW-2013-SS-00040)

RESOLUTION NO. 15-096

1 **WHEREAS, the United States Department of Homeland Security, Federal Emergency**
2 **Management Agency (FEMA) has distributed grants to states and tribes to fund**
3 **investments that provide public safety services within their respective**
4 **jurisdictions; and**

5 **WHEREAS, eligible Indian tribes have been designated to receive direct funding from FEMA**
6 **as established in the 9-11 Recommendations Act; and**

7 **WHEREAS, the Tohono O'odham Nation, submitted an application for FY 2013 Tribal**
8 **Homeland Security Grant to enhance public safety planning initiatives within**
9 **the Nation and received award No. EMW-2013-SS-00040 for the period of**
10 **performance from September 1, 2013 through August 31, 2015; and**

11 **WHEREAS, the Office of Emergency Management has prepared the attached FY 2015 budget**
12 **for the budget period of September 1, 2014 through August 31, 2015; and**

13 **WHEREAS, the Domestic Affairs and the Budget and Finance Committees of the Legislative**
14 **Council have reviewed this budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
16 **the FY 2015 Office of Emergency Management budget of carryover funds and**
17 **authorizes the Office of Emergency Management to expend the unobligated**
18 **funds from the 2013 Tribal Homeland Security Grant Award No. EMW-2013-SS-**
19 **00040 in the amount of \$543,023.19 and to utilize the Nation's resources pending**
20 **reimbursement from the grantor.**

21 **BE IT FURTHER RESOLVED the 2013 Tribal Homeland Security Grant shall be expended in**
22 **accordance with the terms and conditions of the grant for the budget period of**
23 **September 1, 2014 to August 31, 2015.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
25 **Tohono O'odham Nation Chairperson and any designated official to expend and**
26 **administer the budget as attached, provided that any amendments affecting the**
27 **funds or funding level is submitted for further prior approval by the Tohono**
28 **O'odham Legislative Council.**
