

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Gu-Vo District FY'2015 Budget Amendment No. 1 in the amount of
\$80,000.00 of carry forward funds from FY 2010)**

RESOLUTION NO. 15-098

1 **WHEREAS, the Gu-Vo Administration did submit their Fiscal Year 2015 Budget**
2 **Amendments No. 1; and**

3 **WHEREAS, the Gu-Vo District Governing Council Resolution No. GV-15-018 amends the**
4 **FY'2015 budget for the Administration with a carry forward of funds in the**
5 **amount of \$80,000.00 from Fiscal Year 2010; and**

6 **WHEREAS, the Gu-Vo District Administration's FY'2015 Budget Amendment No. 1 adds Line**
7 **Item number 7230-Lease/Rentals in the amount of \$2,000.00 and an increase to**
8 **Line Item number 7615-Donation/Contribution in the amount of \$193,743.72**
9 **with additional language to the justification to state – "PROVIDE FUNDING FOR**
10 **THE PURCHASE OF (5) FIVE MOBILE HOMES FOR THE FLOOD VICTIMS OF JULY**
11 **2014 – (3)-ONE BEDROOM MOBILE HOMES, (1)-THREE BEDROOM MOBILE HOME,**
12 **AND (1)-FOUR BEDROOM MOBILE HOME; TO BE PURCHASED BY THE**
13 **ADMINISTRATION AND DONATED TO THE FLOOD VICTIMS. "MUST HAVE 3**
14 **QUOTES"; and**

15 **WHEREAS, the Budget and Finance Committee of the Legislative Council has reviewed this**
16 **budget and recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
18 **approves the Gu-Vo District FY'2015 Budget Amendment No. 1 in the amount of**
19 **\$80,000.00 of carry forward funds from FY 2010.**

20 **BE IT FURTHER RESOLVED that the Gu-Vo District Administration's FY'2015 Budget has been**
21 **increased by \$80,000.00 increasing the total overall Gu-Vo District FY'2015**
22 **Budget to \$2,218,264.22.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **District Chairperson and any designated official to expend and administer the**
25 **budget as attached, provided that any amendments affecting the funds or**
26 **funding level is submitted for further prior approval by the Toho O'odham**
27 **Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
29 **day of APRIL, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
32 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
34 **June 18, 1934 (48 Stat.984).**
