

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 14-459, and Approving San Lucy District FY 2015
Budget Amendment No. 1)**

RESOLUTION NO. 15-099

1 **WHEREAS, Tohono O'odham Legislative Council passed Resolution No. 14-459, "Approving**
2 **San Lucy District FY 2015 Budget" in the amount of \$1,833,832.31; and**

3 **WHEREAS, Resolution No. 14-459, further requires that any amendments/modifications**
4 **affecting the funds or funding level shall be submitted for further prior**
5 **approval by the Tohono O'odham Legislative Council; and**

6 **WHEREAS, the San Lucy District Council passed Resolution No. SL 02-11-15, "Approving San**
7 **Lucy District FY 2015 - Elderly Program Budget Amendment No. 1", which**
8 **incorporates line items 660 - Travel Expenses adding \$700.00 to cover**
9 **anticipated expenses and further incorporates \$1,750.00 in line item 860-**
10 **Special Activities, thereby increasing the budget by \$2,450.00; and**

11 **WHEREAS, the San Lucy District Council passed Resolution No. SL 02-12-15, "Approving San**
12 **Lucy District FY 2015 - Health Program Budget Amendment No. 1", which**
13 **incorporates line item 650 - Tuition and Registration and 660 - Travel Expenses**
14 **adding \$1,300.00 to line item 650 and \$2,000.00 to line item 660 to cover**
15 **anticipated expenses; thereby increasing the budget by \$3,300.00; and**

16 **WHEREAS, the San Lucy District Council passed Resolution No. SL 02-13-15, "Approving San**
17 **Lucy District FY 2015 - Administration Budget Amendment No. 1", which**
18 **incorporates line item 650 - Tuition and Registration and 660 - Travel Expenses**
19 **adding \$2,600.00 to line item 650 and \$8,600.00 to line item 660 to cover**
20 **anticipated expenses; thereby increasing the budget by \$11,200.00; and**

21 **WHEREAS, the San Lucy District FY 2015 Budget is increased from \$1,833,832.31 to**
22 **\$1,850,782.31; and**

23 **WHEREAS, the Budget and Finance Committee of the Legislative Council has reviewed this**
24 **budget amendment and recommends its approval.**

25 **NOW, THEREFORE BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
26 **approves San Lucy District FY 2015 Budget Amendment No. 1 which will:**

- 27 1. **Approve San Lucy District FY 2015 - Elderly Program Budget Amendment**
28 **No. 1 which increased the program budget by \$2,450.00, as attached.**
29 2. **Approve San Lucy District FY 2015 - Health Program Budget Amendment**
30 **No. 1 which increased the program budget by \$3,300.00, as attached.**


1 3. Approve San Lucy District FY 2015 - Administration Budget Amendment No.
2 1 which increased the budget by \$11,200.00, as attached.


3 BE IT FURTHER RESOLVED that the San Lucy District FY 2015 Budget Amendment No. 1
4 increases the annual budget by \$16,950.00 and further increases the aggregate
5 amount from \$1,833,832.31 to \$1,850,782.31.

6 BE IT FURTHER RESOLVED that the accumulated interest from various San Lucy District
7 accounts are appropriated in the amount of \$16,950.00, to fund the budget
8 amendments.

9 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
10 District Chairperson and any other designated official to expend and administer
11 the budget as attached, provided that any amendments/modifications affecting
12 the funds or funding level shall be submitted for further prior approval by the
13 Tohono O'odham Legislative Council.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH
15 day of APRIL, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-
16 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
17 Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
18 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
19 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
20 June 18, 1934 (48 Stat.984).
