

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY2015 Budget Amendment No. 01 for the Ventana Community,
Hikiwañ District)

RESOLUTION NO. 15-100

1 **WHEREAS, the Tohono O'odham Legislative Council appropriated a Gaming Distribution to**
2 **the Hikiwañ District in the amount of \$1,515,841.62 for FY2015; and**

3 **WHEREAS, the Hikiwañ District by Resolution HDC-15-041 appropriated \$40,000 to each of**
4 **the Seven (7) Communities within its district; and**

5 **WHEREAS, the Ventana Community presented a modified budget to change the wording in**
6 **Line Item #7035 and to add Line Item 7400 "RM - Equipment", as shown in the**
7 **budget attached; and**

8 **WHEREAS, the Hikiwañ District Council by Resolution No. HDC-15-017 reviewed and**
9 **approved the FY2015 Budget Amendment No. 01 for the Ventana Community;**
10 **and**

11 **WHEREAS, the Budget and Finance Committee on March 26, 2015 reviewed and**
12 **recommends approval of the FY2015 Budget Amendment No. 01 for the Ventana**
13 **Community of the Hikiwañ District.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
15 **approves the FY2015 Budget Amendment No. 01 for the Ventana Community,**
16 **Hikiwañ District.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chairperson and any designated official to expend and administer the budget as**
19 **attached, provided that any amendments/modifications affecting the funds or**
20 **funding levels shall be submitted for further prior approval by Tohono O'odham**
21 **Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
23 **day of APRIL, 2015 at a meeting at which a quorum was present with a vote of 2,444.5 FOR; 502.0**
24 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
25 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
28 **June 18, 1934 (48 Stat.984).**


