**with carryover funds from FY 2013 in the amount of \$43,654.32)**

**RESOLUTION NO. 15-103**

1   **WHEREAS, the Tohono O'odham Legislative Council, on September 24, 2014, passed**  
2                   **Resolution No. 14-431, "Approving the Sif-Oidak District FY 2015 Sif-Oidak**  
3                   **District Budget in the amount of \$2,070,152.54"; and**

4   **WHEREAS, the Sif-Oidak District Council, on March 14, 2015, passed Resolution No. SODC**  
5                   **15-032, "Approving the FY 2015 Sif-Oidak District Administration Budget**  
6                   **Amendment/Modification #1 in the amount of \$47,418.45"; and**

7   **WHEREAS, the Administration Budget Amendment decreases line item (624) Bonus by**  
8                   **\$3,764.13; and**

9   **WHEREAS, the Budget is amended by adding a new line item (613) Debt Payment for**  
10                   **\$24,918.45 and Increasing line items: (615) Payroll Services by \$3,000; (614)**  
11                   **Temporary Labor by \$3,500; (720) Office Supplies by \$3,500; (751) Leases &**  
12                   **Rentals by \$6,000; (752) Office Equipment by \$1,500; and (810) Professional**  
13                   **Services by \$5,000 for a total of \$43,654.32 to cover additional expenses for the**  
14                   **remainder of the Fiscal Year; and**

15   **WHEREAS, the Administration Budget is increased by adding \$43,654.32 using the FY 2013**  
16                   **Surplus funding thereby increasing the Sif-Oidak District Administration**  
17                   **Budget from \$998,729.06 to \$1,042,383.38; and**

18   **WHEREAS, the Legislative Budget and Finance Committee did review the FY 2015 Sif-Oidak**  
19                   **District Administration Budget Amendment #1 and recommends approval.**

20   **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
21                   **approves the FY 2015 Sif-Oidak District Administration Budget Amendment #1.**

22   **BE IT FURTHER RESOLVED that the Administration Budget is increased by adding \$43,654.32**  
23                   **using the FY 2013 Surplus funding.**

24   **BE IT FURTHER RESOLVED that the Administration Budget shall reflect the increase from**  
25                   **\$998,729.06 to \$1,042,383.38.**

26   **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
27                   **District Chairperson and any designated official to expend and administer the**  
28                   **budget as attached, provided that any Amendments/Modifications affecting the**  
29                   **funds or funding level is submitted for further prior approval by the Tohono**  
30                   **O'odham Legislative Council.**
