

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2015 Sif-Oidak District Community Services Budget Amendment #1
with carryover funds from FY 2013 in the amount of \$21,156.71)

RESOLUTION NO. 15-104

1 **WHEREAS, the Tohono O'odham Legislative Council, on September 24, 2014, passed**
2 **Resolution No. 14-431, "Approving the Sif-Oidak District FY 2015 Sif-Oidak**
3 **District Budget in the amount of \$2,070,152.54"; and**

4 **WHEREAS, the Sif-Oidak District Council, on March 14, 2015, passed Resolution No. SODC**
5 **15-033, "Approving the FY 2015 Sif-Oidak District Community Services Budget**
6 **Amendment/Modification #1 in the amount of \$29,760.87"; and**

7 **WHEREAS, on March 14, 2015, the Sif-Oidak District Council approved Resolution No. SODC**
8 **15-034, "Approving the Establishment of a Policy Task Force" within Line Item**
9 **(640) Committee Fees and moving around \$5,700.00 to cover the new Policy Task**
10 **Force; and**

11 **WHEREAS, the budget is amended by decreasing line items specifically from (624) Bonus by**
12 **\$4,604.16 and (861) Holiday Gift Cards by \$4,000 for a total of \$8,604.16.**
13 **Increasing line items (750) Capital Equipment by \$26,260.87; and (810)**
14 **Professional Services by \$3,500.00 to cover additional expenses for the**
15 **remainder of the Fiscal Year; and**

16 **WHEREAS, Line Item (640) Committee Fees is decreasing Livestock Committee stipends by**
17 **\$1,000.00; Water Committee Stipends by \$1,700.00 and Youth Council Stipends**
18 **by \$3,000.00 and create a Policy Task Force with 5 Council Members at \$95.00 per**
19 **meeting for 12 meetings; and**

20 **WHEREAS, the Community Services Budget is amended by adding new dollars from the FY**
21 **2013 Surplus funding in the amount of \$21,156.71 and increasing the Budget**
22 **from \$819,775.87 to \$840,932.58; to cover additional expenses for the remainder**
23 **of the Fiscal Year; and**

24 **WHEREAS, the Legislative Budget and Finance Committee did review the FY 2015 Sif-Oidak**
25 **District Community Services Budget Amendment/Modification #1 and**
26 **recommends approval.**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
28 **approves the FY 2015 Sif-Oidak District Community Services Budget Amendment**
29 **#1.**



5 **budget as attached, provided that any Amendments/Modifications affecting the**
6 **funds or funding level is submitted for further prior approval by the Tohono**
7 **O'odham Legislative Council.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
9 **day of APRIL, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**
10 **AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**
11 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
12 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
13 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
14 **June 18, 1934 (48 Stat.984).**




