1 **WHEREAS, the Sif-Oidak District Council passed on March 14, 2015 Resolution No. SODC 15-**
2 **036, "Approving the Sif-Oidak District FY 2014 Capital Budget Carryover in the**
3 **Amount of \$342,847.23 to FY 2015" as attached; and**

4 **WHEREAS, the Legislative Budget & Finance Committee did review the attached Sif-Oidak**
5 **District FY 2015 Capital Budget and recommends approval.**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
7 **approves the FY 2015 Sif-Oidak District Capital Budget with carryover funds**
8 **from FY 2014 in the amount of \$342,847.23.**

9 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
10 **District Chairperson and any designated official to expend and administer the**
11 **budget as attached, provided that any Amendments/Modifications affecting the**
12 **funds or funding level is submitted for further prior approval by the Tohono**
13 **O'odham Legislative Council.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
15 **day of APRIL, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**
16 **AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**
17 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
18 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
20 **June 18, 1934 (48 Stat.984).**
