1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications**
7 **and making recommendations to the Legislative Council regarding the**
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**
9 **and**

10 **WHEREAS, the Enrollment Program has determined that a number of resolutions**
11 **approving applicants for membership contain misspellings in the names of**
12 **applicants; or incorrect roll numbers; and**

13 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 37-80, 127-**
14 **83, 132-83, 06-84, 224-87, 91-040, 93-056, 94-109, 97-256, 98-429, 98-034, 98-123,**
15 **99-004, 2000-233, 01-589, 05-472, 09-229, 13-216, and 14-254 be amended to**
16 **reflect the correct name spelling or roll numbers for the individuals identified**
17 **in the Amending Enrollment Resolution List April 2015, which is incorporated**
18 **by this reference.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
20 **Resolution Nos. 37-80, 127-83, 132-83, 06-84, 224-87, 91-040, 93-056, 94-109, 97-**
21 **256, 98-429, 98-034, 98-123, 99-004, 2000-233, 01-589, 05-472, 09-229, 13-216, and**
22 **14-254 are amended upon the effective date of those resolutions to reflect the**
23 **corrected names or roll numbers identified in the Amending Enrollment**
24 **Resolution List April 2015.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
26 **day of APRIL, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
28 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**
29 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**
30 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
