

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving and Authorizing Budget Amendment #1 of Hewel Ni'ok's KOHN CPB CSG**  
**FY 2015 Budget; and adjusting the Indirect Cost Rate)**

**RESOLUTION NO. 15-112**

1 **WHEREAS, by Resolution #14-381, the Tohono O'odham Legislative Council (Council)**  
2 **approved and authorized the fiscal year budget of Hewel Ni'ok's KOHN CPB CSG**  
3 **(Grant) for 2015; and**

4 **WHEREAS, the Tohono O'odham Nation (Nation) received from the Corporation for Public**  
5 **Broadcasting (CPB) of the grant allocation for the current grant year 2015 - 2016**  
6 **in the amount of \$216,212.00 which is an increase of \$16,553.68; and**

7 **WHEREAS, at fiscal year-end September 30, 2014, the stand alone audit identified**  
8 **\$34,229.00 remained uncommitted which is permitted by CPB to be carried**  
9 **forward into the current fiscal year 2015; and**

10 **WHEREAS, Hewel Ni'ok management has prepared the attached Amendment #1,**  
11 **incorporated into this resolution by this reference, to obligate the total**  
12 **available funds, \$50,782.68, for the current fiscal year; and**

13 **WHEREAS, obligating these funds will also adjust the calculated administrative support,**  
14 **commonly known as Indirect Cost (IDC), by \$481.11; and**

15 **WHEREAS, Amendment #1 as presented, provides additional allocations for operational**  
16 **line items and adjusts the calculated IDC; and**

17 **WHEREAS, budget amendment #1 of Hewel Ni'ok's KOHN CPB CSG FY 2015 budget was**  
18 **presented to the Cultural Preservation and Budget and Finance Committees for**  
19 **review and recommended approval.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the**  
21 **attached budget amendment #1 for the Hewel Ni'ok's KOHN CPB CSG FY 2015**  
22 **budget is hereby approved and authorized as presented to provide additional**  
23 **allocations for operational line items and adjusts the calculated IDC.**

24 **BE IT FURTHER RESOLVED that the net adjustment of amendment #1 increases Hewel Ni'ok's**  
25 **KOHN CPB CSG FY 2015 budget by \$51,263.79 from \$239,723.37 to \$290,987.16.**

26 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
27 **Chairman and any designated official to expend and administer the budget as**  
28 **attached, provided that any amendments affecting the funds or funding level is**  
29 **submitted for further prior approval by the Tohono O'odham Legislative**  
30 **Council.**
