**RESOLUTION NO. 15-118**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications**  
7 **and making recommendations to the Legislative Council regarding the**  
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**  
9 **and**

10 **WHEREAS, the Enrollment Program has determined that a number of resolutions**  
11 **approving applicants for membership contain misspellings in the names of**  
12 **applicants; or incorrect roll numbers; and**

13 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 74-83, 95-**  
14 **082, 97-144, 97-256, 98-034, 98-123, 98-429, 98-492, 99-360, 2000-176, 01-355, 02-**  
15 **280, 03-280, 04-659, 06-449, and 06-328 to be amended to reflect the correct**  
16 **name spelling and/or roll numbers for the individuals identified in the**  
17 **Amending Enrollment Resolution List May 2015, which is incorporated by this**  
18 **reference.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**  
20 **Resolution Nos. 74-83, 95-082, 97-144, 97-256, 98-034, 98-123, 98-429, 98-492, 99-**  
21 **360, 2000-176, 01-355, 02-280, 03-280, 04-659, 06-449, and 06-328 are amended**  
22 **upon the effective date of those resolutions to reflect the corrected names or roll**  
23 **numbers identified in the Amending Enrollment Resolution List May 2015.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup>**  
25 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
27 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**  
28 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**  
29 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
30 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
