

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment #1 to the FY 2015 Bureau of Indian Affairs Judicial Service
P.L. 93-638 budget to include FY 2014 Carry Forward Savings)

RESOLUTION NO. 15-121

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No.14-348 approved the FY**
2 **2015 Bureau of Indian Affairs Budgets under the P.L. 93-638 Master Contract**
3 **which includes the Judicial Services budget; and**

4 **WHEREAS, the Judicial Branch has been provided a copy of P.L. 93-638 BIA Master Contract,**
5 **Modification 50 distributing the first FY2015 Tribal Priority Allocation of**
6 **\$72,434.00 and Modification 55 distributing the Final Allocation of \$297,517.00**
7 **for a total of \$369,951.00 for Judicial Services, less than the approved budget**
8 **total; and**

9 **WHEREAS, the attached Financial Status Report, indicates FY 2014 carry forward saving in**
10 **the amount of \$304,155.10, \$11,190.00 will be used to cover the shortfall for the**
11 **approved FY 2015 budget, which leaves carry forward savings in the amount of**
12 **\$292,965.10; and**

13 **WHEREAS, the Judicial Branch has prepared the attached budget to utilize the remaining**
14 **P.L. 93-638 carry forward savings; and**

15 **WHEREAS, the attached FY 2015 budget amendment #1 would increase the Indirect Cost**
16 **charges of \$77,790.88 by \$51,630.18 for a total of \$129,421.06; and**

17 **WHEREAS, the total amount of the Judicial Services budget is increased from \$458,931.88 to**
18 **\$803,527.16; and**

19 **WHEREAS, the attached FY2015 budget amendment #1 would add the following new line**
20 **item: 7210 Dues and Subscriptions; 8060 Alterations and Renovations; and**

21 **WHEREAS, the Tohono O'odham Legislative Judiciary and Budget and Finance Committees**
22 **have reviewed this budget amendment and recommend its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
24 **approves the attached FY 2015 Bureau of Indian Affairs Judicial Service P.L. 93-**
25 **638 Budget Amendment #1.**

26 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
27 **Chief Judge and any designated official to expend and administer the budget as**
28 **attached, provided that any amendments affecting the funds or funding level**
