2 **Resolution No. SD-28-14 and Tohono O'odham Legislative Council Resolution**
3 **No. 14-130 approved Cowlic Community's Fiscal Year 2014 Mining Royalties**
4 **Budget and it's justifications; and**

5 **WHEREAS, Cowlic Community did decide to carryover the unexpended funds from the**
6 **Fiscal Year 2014 Mining Royalties Budget into Fiscal Year 2015; and**

7 **WHEREAS, Cowlic Community carry over amount from Fiscal Year 2014 to Fiscal Year 2015**
8 **is in the amount of \$14,641.34 and will be put into line items #7035 Building**
9 **Materials at an amount of \$4,320.67, #7355 Professional Services in the amount**
10 **of \$4,320.67 and 7430 RM Grounds in the amount of \$6,000.00; and**

11 **WHEREAS, Cowlic Community has prepared and acquired approvals of the attached budget**
12 **to carry over funds from Fiscal Year 2014 to Fiscal Year 2015 with Cowlic**
13 **Community Resolution No. CC 14-15 and Sells District Council Resolution No.**
14 **SD-33-15; and**

15 **WHEREAS, the Budget and Finance Committee of the Tohono O'odham Legislative Council**
16 **has reviewed the budget and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
18 **the Cowlic Community FY 2015 Mining Royalties Budget with carryovers from FY**
19 **2014 Mining Royalties in the Amount of \$14,641.34.**

20 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes**
21 **the Sells District Chairperson and any designated District Official to expend and**
22 **administer the budget as attached, provided that any modifications or**
23 **amendments affecting the funds or funding levels of the budget shall be**
24 **submitted for further prior approval by the Tohono O'odham Legislative**
25 **Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
27 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
32 **June 18, 1934 (48 Stat.984).**
