

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2015 Carry Forward Budget for Child Care & Development
Fund-Mandatory Funds in the amount of \$201,145.00 from Grant Year 2014)**

RESOLUTION NO. 15-125

1 WHEREAS, the Tohono O'odham Nation is operating the Division of Early Childhood
2 Development for its young members and providing for their welfare through
3 various programs and services designed to meet their special needs; and

4 WHEREAS, the Department of Health and Human Services, Administration for Children and
5 Families has awarded the Tohono O'odham Nation the Child Care &
6 Development Fund for Grant Year 2014 to implement Child Care Services
7 through the Division of Early Childhood Development; and

8 WHEREAS, the Child Care & Development Fund is a multi-year grant in which Grant Year
9 2014 Carry Forward Mandatory Funds will be obligated and liquidated by
10 September 30, 2015; and

11 WHEREAS, the FY 2014 carry forward amount of \$201,145.00 in Child Care & Development
12 Mandatory funds has been used to create this FY 2015 budget; and


13 WHEREAS, the Human Resources Development and the Budget and Finance Committees of
14 the Legislative Council have reviewed this Budget and recommend its approval.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
16 approve the FY 2015 Carry Forward Budget for Child Care & Development Fund-
17 Mandatory Funds in the amount of \$201,145.00 from Grant Year 2014.

18 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
19 Chairperson and any designated official to expend and administer the budget as
20 attached, provided that any amendment affecting the funds or funding level is
21 submitted for further prior approval by the Tohono O'odham Legislative
22 Council.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH
24 day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-
25 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
26 Article VI, Section 1(d)(2)(3) & (f) of the Constitution of the Tohono O'odham Nation, adopted by
27 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
28 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
29 June 18, 1934 (48 Stat.984).
