1 **WHEREAS, the Tohono O'odham Nation is operating the Division of Early Childhood**  
2 **Development for its young members and providing for their welfare through**  
3 **various programs and services designed to meet their special needs; and**

4 **WHEREAS, the Department of Health and Human Services, Administration for Children and**  
5 **Families has awarded the Tohono O'odham Nation the Child Care &**  
6 **Development Fund for Grant Year 2014 to implement Child Care Services**  
7 **through the Division of Early Childhood Development; and**

8 **WHEREAS, the Child Care & Development Fund is a multi-year grant in which Grant Year**  
9 **2014 Carry Forward Discretionary Funds will be obligated and liquidated by**  
10 **September 30, 2015; and**

11 **WHEREAS, the FY 2014 carry forward amount of \$113,688.00 in Child Care & Development**  
12 **Discretionary funds has been used to create this FY 2015 budget; and**


13 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**  
14 **the Legislative Council have reviewed this Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
16 **approve the FY 2015 Carry Forward Budget for Child Care & Development Fund-**  
17 **Discretionary Funds in the amount of \$113,688.00 from Grant Year 2014.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
19 **Chairperson and any designated official to expend and administer the budget as**  
20 **attached, provided that any amendment affecting the funds or funding level is**  
21 **submitted for further prior approval by the Tohono O'odham Legislative**  
22 **Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup>**  
24 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**  
25 **AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
26 **Article VI, Section 1(d)(2)(3) & (f) of the Constitution of the Tohono O'odham Nation, adopted by**  
27 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
29 **June 18, 1934 (48 Stat.984).**
