

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Amendment No. 1 to Federal Lobbying Contract for FY 2015 with  
Dentons US, LLP)**

RESOLUTION NO. 15-128

1 **WHEREAS, by Resolution No. 14-494 the Nation approved the FY 2015 Federal Lobbying**  
2 **Contract for work related to the Economic Development Delegation budget; and**  
3 **WHEREAS, the Economic Development Delegation has reviewed Amendment No. 1 to the FY**  
4 **2015 Federal Lobbying Contract; and**  
5 **WHEREAS, the Contract as amended by Amendment No. 1 would be funded by existing**  
6 **Economic Development Delegation FY 2015 Budget line items 7335 Lobbying**  
7 **and 7355 Professional Services, and therefore would not require an additional**  
8 **appropriation of funds.**

9 **NOW, THEREFORE, BE IT RESOLVED that:**

- 10           **1. The Tohono O'odham Legislative Council approves Amendment No. 1 to the**  
11           **FY 2015 Federal Lobbying Contract with the law firm of Dentons US, LLP,**  
12           **substantially in the form attached hereto.**  
13           **2. The Chairperson of the Nation is authorized to execute Amendment No. 1 to**  
14           **the FY 2015 Federal Lobbying Contract.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>**  
16 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**  
17 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
18 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
19 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
21 **June 18, 1934 (48 Stat.984).**


