1 **WHEREAS, the Tohono O'odham Nation applied for and was awarded the Department of**  
2 **Justice (DOJ), Office of Justice Programs (OJP), Sex Offender Registration,**  
3 **Tracking, Enforcement and Notification Division Grant, Grant No. 2011-AW-BX-**  
4 **0018; and**

5 **WHEREAS, the grant was accepted by the Tohono O'odham Legislative Council by**  
6 **Resolution No. 11-539 from October 1, 2011 through March 31, 2013; and**

7 **WHEREAS, a grant extension of 12 months was requested and approved the Tohono**  
8 **O'odham Legislative Council Resolution No. 13-176 extending the performance**  
9 **period to March 31, 2014; and**

10 **WHEREAS, a second grant extension of 12 months was requested and approved by Tohono**  
11 **O'odham Legislative Council Resolution No. 14-408 extending the performance**  
12 **period to March 31, 2015; and**

13 **WHEREAS, a third grant extension of six months was submitted and approved for a period**  
14 **of six months extending the performance period to September 30, 2015; and**

15 **WHEREAS, the Tohono O'odham Nation Police Department has prepared a FY15 budget and**  
16 **submitted for approval; and**

17 **WHEREAS, the Domestic Affairs and Budget and Finance Committees, of the Tohono**  
18 **O'odham Legislative Council have reviewed this budget and recommends its**  
19 **approval.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
21 **accepts the third extension to the DOJ, OJP, Sex Offender Sentencing,**  
22 **Monitoring, Apprehending, Registering and Tracking Office, Sex Offender**  
23 **Registration, Tracking, Enforcement and Notification Division Grant, Grant No.**  
24 **2011-AW-BX-0018 and approves the attached FY 2015 budget in the amount of**  
25 **\$57,992.05 effective April 1, 2015 through September 30, 2015.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**  
27 **the Chairperson and any designated official to expend and administer the**  
28 **budget as attached, provided that any amendments affecting the funds or**  
29 **funding level is submitted for further prior approval by the Tohono O'odham**  
30 **Legislative Council.**
