

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Amendment No. 2 to the 638 Corrections Program FY 2015 budget)**

RESOLUTION NO. 15-133

1 **WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Ranger and**
2 **Corrections Programs under the P.L. 93-638 BIA Master Contract; and**

3 **WHEREAS, the FY 2015 Corrections Program budget was approved by the Tohono O'odham**
4 **Legislative Council through Resolution No. 14-348; and**

5 **WHEREAS, the Tohono O'odham Nation Corrections Program received carryover funding**
6 **and has submitted a budget amendment No. 2 for its FY 2015 budget; and**

7 **WHEREAS, amendment No. 2 allows the creating of 7340 Public Relations and 7500 Capital**
8 **Equipment; and**

9 **WHEREAS, the amendment will increase the Personnel and Operational Expense line items;**
10 **and**

11 **WHEREAS, the Domestic Affairs and Budget and Finance Committees of the Legislative**
12 **Council have reviewed this budget amendment and recommends its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
14 **approves the Budget Amendment No. 2 for the Corrections Program FY 2015**
15 **budget attached hereto:**

- 16 1. **Approve to incorporate carryover savings in the amount of \$3,984,825.58.**
- 17 2. **Approve creating new line items and increasing Personnel and**
18 **Operational line items.**
- 19 3. **Approve increasing IDC to \$1,040,938.20 and increasing overall budget**
20 **amount to \$7,967,751.95**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**
22 **the Chairperson and any designated official to expend and administer the**
23 **budget as attached, provided that any amendments affecting the funds or**
24 **funding level is submitted for further prior approval by the Tohono O'odham**
25 **Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
27 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926,9 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
32 **June 18, 1934 (48 Stat.984).**
